AGREEMENT

Net, 15 days from Invoice. The entire amount on all invoices are to be paid by 15 days from the Invoice date. Claims arising from invoices must be made within five working days.

If Plumbers Best Supply LLC (Seller) does not receive payment for entire amount of invoice from Applicant(s) (Buyer) more than 25 days after the date of the invoice, all accounts will be placed on hold until paid in full. Seller may assess 1.5 % interest (18% annually) on unpaid amounts on the invoice. Interest begins accruing on the invoice due date. If Buyer fails to make any payment to Seller when due, the Buyer's entire account(s) with Seller shall become immediately due and payable and Seller may suspend current and further performance under any order with Buyer. Seller may refer collection of the unpaid amount to an attorney or collection services. The Applicant(s) agrees to pay all reasonable, court, attorney's, litigation, and any other collections fees.

If Applicant(Buyer) is unable to make payment and requires a payment plan, Buyer must contact Plumbers Best Supply LLC (Seller) before the due date on the invoice. If Buyer requests a payment plan after the due date on the invoice, Seller may assess late fees, accumulated interest, attorney's fees, and any applicable collection fees. Nothing in this section requires Seller to accept any payment plan.

Applicant (Buyer) agrees to waive any and all privileges and rights which they may have under Chapter47, Florida Statutes, relating to venue, as it now exists or may thereafter be amended, and under any other statute, administrative provision or state court in Seminole County, Florida.

A tax-exempt certificate is required in order to receive tax credit.

Applicant(s) agree to immediately notify Plumbers Best Supply LLC (Seller) in writing of any changes in ownership or form of said business, addresses, and contact information at 401E 1st Street #83, Sanford, Florida, 32772.
